

MINUTES OF THE REGULAR MEETING

DANBURY TOWN COUNCIL

MARCH 24, 2010

The regular meeting of the Danbury Town Council was held at the Ralph J. Scott Memorial Town Hall on March 24, 2010 at 7:00 p.m.

Present were Mayor Janet Whitt, Mike Barsness, Andrew Mathys, Olivia Shelton, Wendi Uselton, Town Administrator Byron Ellis, Town Attorney Mike Bruce and Town Clerk Dianne Starnes. Others present were Michael Booth, Becky East, Gary East and Deborah Fuschetti.

Mayor Whitt called the meeting to order at 7:00 p.m.

On motion of Mike Barsness, seconded by Andrew Mathys, it was unanimously

RESOLVED that the agenda be amended to include discussion on privilege license fees.

Public Comments – Deborah Fuschetti shared written comments with Council regarding parking on a public street. The comments were read by Gary East.

Recommendations from Planning and Zoning Board – John Turpin sent the Council a summation of the Planning Board meeting that was held on March 22, 2010.

Healthy Carolinians will host a 5K/Family Fun Run on June 5, 2010. The Council supports the run.

Business Center/Internet Access and Raymond Brown Zoning Map applications were reviewed.

Kenneth Carrick's application to serve on the Danbury Planning and Zoning Board was reviewed. Olivia Shelton suggested that Mr. Carrick attend the next meeting to let the Council meet him.

Parking behind the Board of Education offices was discussed and will be discussed further at the next meeting.

Mayor Whitt gave a report on the recent COG meeting: the Piedmont Triad Council of Governments will consider whether or not to merge with the Northwest Piedmont Council of Governments to become one Council. Mayor Whitt said she will not support the merger.

RESOLVED that a public hearing be held on April 28, 2010 regarding Raymond Brown's Map Amendment request.

RESOLVED that the regular Town Council meeting scheduled for May 26, 2010 be rescheduled for May 19, 2010 at 7 pm at the Danbury Public Library.
