DANBURY TOWN COUNCIL

NOVEMBER 28, 2012

A regular meeting of the Danbury Town Council was held at the Ralph J. Scott Memorial Town Hall on October 2, 2012

Present were Mayor Janet Whitt; Council Members Ken Carrick, Gary East, Olivia Shelton and Wendi Spraker; Town Administrator Mike Barsness was also present. Absent were Town Clerk Dianne Starnes and Town Attorney Mike Bruce.

Mayor Whitt called the meeting to order at 7:00 p.m.

Town Administrator Mike Barsness spoke to the need to update the Town of Danbury Master Plan and asked the Council to adopt a resolution authorizing such action.

RESOLVED that the December Council Meeting be rescheduled for Wednesday, January 9, 2013, at which time the Council will begin work on the master plan.

Mr. Barsness also gave the Administrator's report which included discussion regarding the town's liability for activity occurring on the town sidewalk during the *Christmas in Danbury* event on December 2, 2012. It was decided to ask the Sheriff's Office for an off-duty deputy between the hours of 2pm-6pm to monitor vehicular traffic and provide a measure of safety for pedestrians.
