

# BUDGET ORDINANCE FOR THE TOWN OF DANBURY

FY 2026-27 ORDINANCE 2026-01

**BE IT ORDAINED** by the Town Council of the Town of Danbury, North Carolina:

**Section 1:** It is estimated that the following revenues will be available in the General Fund for the fiscal year beginning July 1, 2026, and ending June 30, 2027:

**Section 3:** For purposes of raising the revenue listed as Ad Valorem Taxes and Motor Vehicle Tax in Section 1 of this ordinance, there is hereby levied a tax at the rate of twenty-five cents (\$0.25) per one-hundred dollars (\$100) valuation of property as listed for taxes as of February 6, 2026, based on Total Estimated Valuation of \$17,111,398.00, with an expected collection rate of ninety-seven (97) percent.

**Section 4:** The Finance Officer is authorized to transfer appropriations contained in Section 2, as necessary, to manage unforeseen budgetary needs, with the following conditions:

- Amounts transferred between line items may be made without limitation, except that no transfer may be made resulting in a change to contract terms or recurring obligations, such as salaries or garbage collection fees, without a formal budget amendment.
- A report on such transfer shall be made at the next regular meeting of the town council and be recorded in the official minutes.

**Section 5:** The Minimum Fund Balance for fiscal year 2026-27 is hereby established at 85,800.00.
